“Ute Mountain Ute Reservation Only” MOBILE WAGERING HOUSE RULES

The Account Wagering Rules, the House Rules posted in the Ute Mountain Casino Hotel Sportsbook and the Terms of Service on the Ute Mountain Casino Hotel website (www.utemountaincasino.com), (collectively, “Rules and Terms”) apply to account wagering. Ute Mountain Casino Hotel Sportsbook reserves the right to add, change, or modify the Rules and Terms at any time. Customer agrees to be bound by such changes.

OPENING A MOBILE WAGERING ACCOUNT

All account applicants must be at least 21 years of age.

1. Must complete a wagering account application
2. Submit a valid:
 - driver’s license
 - Passport
 - government ID
 - Tribal ID
 - Visa

Prior to opening an account

A customer will be provided with a copy of the Ute Mountain Casino Hotel Account Wagering Rules and procedures for account wagering.

It is the customer’s responsibility to be aware of all wagering rules, including subsequent changes.

Upon opening a mobile account, Ute Mountain Casino Hotel will provide each customer with:

- an account number
- password (reasonably designed to prevent the acceptance of wagers from persons other than the customer for whom the wagering account was established).

A Ute Mountain Casino Hotel mobile account is for the personal use of the registered account holder and is not transferable.

It is the Customer’s responsibility to maintain the **secrecy** of his/her account number and password.

If the customer feels that his/her account number and/or password have been compromised, he/she should **immediately contact** Ute Mountain Casino Hotel Sportsbook.

Ute Mountain Casino Hotel Sportsbook reserves the right to refuse establishment or maintenance of accounts at its sole and absolute discretion.

DEPOSITING FUNDS INTO YOUR MOBILE WAGERING ACCOUNT

Mobile wagering account deposits must be made in person at Ute Mountain Casino Hotel or by approved electronic transfers. The minimum deposit for opening an account is Five Dollars (\$5).

No interest shall accrue on funds deposited in a customer's account.

Funds may not be deposited into a **suspended or closed account**.

Ute Mountain Casino Hotel Sportsbook reserves the right to refuse deposits to accounts for what it deems in its sole discretion to be a good and sufficient reason.

WITHDRAWING FUNDS

Subject to funds involved with pending investigations as described in the Terms of Service, an account holder may withdraw funds from an active account at any time up to the amount of the account balance.

Withdrawal requests must be made at the Ute Mountain Casino Hotel Sportsbook.

Ute Mountain Casino Hotel Sportsbook **reserves the right to request** for proper identification and/or verification of information prior to allowing any withdrawal.

Withdrawals of Ten Thousand Dollars (\$10,000) or more **may require a five (5) day advance notice**.

Ute Mountain Casino Hotel reserves the right to pay withdrawals by check

Withdrawn funds may be mailed to the account holder at the address given.

MOBILE WAGERING

Account wagers will be ***accepted only during specified wagering hours***.

Account holders **may not make wagers from their account while located outside of The Ute Mountain Ute Reservation.**

Placing or attempting to place a wager while outside The Ute Mountain Ute Reservation is not permitted.

When placing a wager, the account holder must provide:

- his/her account number
- password for verification purposes.

All wagers will be verified to the account holder by Ute Mountain Casino Hotel Sportsbook at the time the wager is placed.

The account holder must confirm wager in order to constitute action and will be final and binding.

If an event is locked out during a transaction, there will be no wager.

Wagers cannot be cancelled after the wager is completed. Total wagers may not exceed the balance in a wagering account.

Ute Mountain Casino Hotel Sportsbook determines the minimum and maximum wager on all events.

- The minimum total wager per transaction is \$2.

All wagers are subject to Ute Mountain Casino Hotel Sportsbook's Rules and Terms. Check the account wagering device for the latest odds.

- All odds are subject to change.

Ute Mountain Casino Hotel Sportsbook reserves the right to refuse any wager or delete or limit any selection(s) prior to the acceptance of the wagers.

All wagers must be at full face value.

- Payments on winning account wagers shall be posted to the account holder's wagering account as soon as reasonably practicable after the event is declared official.
- Winnings are taxed in accordance with IRS requirements.
- Any single wager paying 300 times the amount wagered and at least \$600 is taxable income.
 - It is the account holder's responsibility to come to Ute Mountain Casino Hotel Sportsbook and complete the W-2G.
 - If any winnings minus the amount wagered exceed \$5,000, federal taxes are withheld and the balance deposited to the account holder's account. Ute Mountain Casino Hotel will report all W-2G information to the IRS, as required.

Ute Mountain Casino Hotel Sportsbook reserves the right to declare the account wagering system closed for receiving any or all wagers.

Wagers may not be accepted on a suspended account.

ACCOUNT MANAGEMENT

An account holder may request a statement of account showing all account activity during the time period reported by the account statement.

Ute Mountain Casino Hotel Sportsbook reserves the right to suspend or close any account at any time.

CLOSING AN ACCOUNT

An account holder may close his/her account by going to Ute Mountain Casino Hotel Sportsbook.

DISPUTES

In the event of a dispute, the account holder must contact a Ute Mountain Casino Hotel Sportsbook Manager and/or Supervisor.

- The Sportsbook Manager/Supervisor will obtain all information regarding the dispute.
- The Sportsbook Manager/Supervisor will inform the account holder of the name of the Ute Mountain Casino Hotel Sportsbook representative that will be handling the dispute resolution and provide an approximate time that the account holder will be contacted.

- In the event a dispute cannot be resolved to the satisfaction of the account holder, the Ute Mountain Ute Gaming Commission can be contacted at 970-565-8215 to resolve the dispute.
- Decisions of the Ute Mountain Ute Gaming Commission are final.
